

## Special Review Overview

The **Special Review** section of Streamlyne identifies any components of the research that require special regulatory compliance.

In Grants.gov S2S proposals, Special Review selections may also be used to populate forms required by the Sponsor.

Addition of one or more Special Review components will not delay the submission of a proposal.

## **Special Review Types**

#### HUMAN SUBJECTS

Project involves human subjects and will require Institutional Review Board approval prior to the start of research.

- According to <u>45 CFR 46</u>, a human subject is "a living individual about whom an investigator (whether professional or student) conducting research:
  - Obtains information or biospecimens through intervention or interaction with the individual, and uses, studies, or analyzes the information or biospecimens; or
  - Obtains, uses, studies, analyzes, or generates identifiable private information or identifiable biospecimens."

#### **ANIMAL SUBJECTS**

Project involves animal usage and will require Institutional Animal Care and Use Committee approval (IACUC) prior to the start of research.

The IACUC requires that an Animal Protocol be submitted for all educational, research, teaching and testing projects that will utilize live animals or (non-living) tissues from species regulated by the USDA Animal Welfare Act.

### **IT CYBERSECURITY**

Project solicitation or proposal requires safeguards or special handling of Controlled Unclassified Information (CUI) or other sensitive data. This includes projects with a requirement to comply with NIST-Special Publication 800-171 and Cybersecurity Maturity Model Certification.

## Adding a Special Review Component

Compliance approvals are generally required before the research can begin, but investigators should indicate the status of all special review components at the time of proposal submission.

Special review components can be added using the drop-down menu next to the text Add:

#### HUMAN SUBJECTS RESEARCH

- 1. If the proposal involves human subjects research, select "Human Subjects" in the dropdown menu for **Type**.
- 2. This special review component is linked to the Streamlyne IRB Module. The field labeled **Protocol Number** will change to a search field with a magnifying glass icon.
  - a. If an IRB protocol has been initiated in Streamlyne, click the magnifying glass icon to search for the relevant protocol number. The **Approval Status** and other information will be automatically populated if a protocol record exists.
  - b. If an IRB protocol has not yet been initiated, you may select "Not Yet Applied" as the **Approval Status**. No other information is required.
  - c. Alternatively, click **Start Protocol** to automatically create a new blank IRB protocol record and add it to this proposal. This protocol will be available for completion at a later time, and once submitted, its status will automatically update in the proposal and award records.
- 3. Click Add to confirm the selection of a Human Subjects Special Review Component.

#### OTHER SPECIAL REVIEW COMPONENTS

For all special review types except Human Subjects,

1. Select the special review component **Type** from the drop-down menu.

- 2. Select the applicable Approval Status from the drop-down menu:
  - a. Approved
  - b. Exempt
  - c. Not yet applied
  - d. Pending
- 3. (optional) Provide a **Protocol Number**, **Application Date**, and/or **Approval Date** by typing it into the relevant fields. This is recommended for Animal Subjects research in the case that an IACUC application has been submitted.
- 4. Click Add to confirm the Special Review component.
- 5. Once all Special Review components are added, click **Save** at the bottom of the screen.

## **Conflict of Interest**

Submission of project-specific conflict of interest (COI) disclosures for all investigators is required <u>prior</u> to proposal submission for certain sponsors, including Department of Energy (DOE) and Public Health Service (PHS) agencies, such as the National Institutes of Health (NIH).

An "investigator" is someone:

- Defined as the PD/PI and any other person, *regardless of title or position*
- Who is responsible for the design, conduct, or reporting of research funded by PHS, or proposed for such funding
- Which may include, for example, collaborators or consultants




Once Key Personnel are added to the proposal, the status of Conflict of Interest disclosures will be shown in a panel below the Special Review panel. This panel is for information purposes and cannot be edited.

✓ COI Review
All UNM investigators must have completed a conflict of interest disclosure in the last 12 months. Navigate to Main Menu > Conflict of Interest to check the status of your disclosures and/or submit a new Annual Disclosure. Proposals to PHS agencies (e.g., NIH) and DOE must also submit a project-specific disclosure. Navigate to Main Menu > Conflict of Interest > New Project Disclosures to Complete.
